Becoming inverted during an aerial maneuver, whether intentionally or accidentally substantially increases the risk of serious injury and therefore inverted maneuvers are not recommended. I freely accept and fully assume all risks, dangers and hazards associated with the using the Freestyle Terrain Park and the possibility of loss, personal injury or death resulting there from.

**HOLD HARMLESS AGREEMENT**

In consideration of the receipt of a S.E.S. pass and I hereby agree as follows:

I further agree to **HOLD HARMLESS AND INDEMNIFY the Stratton Corporation** from any and all liability for death and or personal injury, medical or other expense or property damage to others, or myself resulting in any way from my use of the ski area premises.

I further agree that (1) any claim, which I may at any time bring for any reason against The Stratton Corporation, its employees and agents, shall be submitted to the jurisdiction of the State or Federal Courts of the State of Vermont and that no claims or actions shall be brought in any other jurisdiction; and (2) any claim shall be governed by the laws of Vermont.
